The specified person who has not submitted the PAN as well as not filed returns; the tax shall be deducted at the higher of the two rates prescribed in sections 206AA and 206AB of the Act.

A non-resident shareholder who does not have the permanent establishment in India is excluded from the scope of the above provision.
